THE DOMINICAN BAR ASSOCIATION (DBA) is an incorporated, interests of the non-profit. national association representing attorneys, and Latino Dominican-American, native Dominican students in the United States judges, law professors, and law the Dominican Republic. Founded in New York City in 1990 as The American Society of Dominican Attorneys, DBA has grown to represent thousands of Latino attorneys and law students across the country. The DBA invites all Latino attorneys as well as others within the profession who subscribe to the goals and philosophy of DBA to become members.

#### **DBA'S MISSION STATEMENT:**

To increase professional opportunities for Dominican-American, native Dominican and Latino attorneys in the U.S. legal profession;

To assist native Dominican lawyers and attorneys of other nationalities in meeting the requirements for the practice of law in the U.S., including assisting foreign attorneys in obtaining the Foreign Legal Consultant License issued by the Court of Appeals of the State of New York and its counterpart in other U.S. states;

To assist in the recruitment and retention of Dominicans and Latinos in U.S. law schools and provide students with mentoring, scholarships and other assistance;

To partner with other bar associations, governmental agencies and community groups to foster greater participation in the U.S. legal system by the Dominican and Latino communities;

To address issues of concern to the Dominican and Latino communities in the U.S.;

To safeguard the civil rights of the Dominican and Latino communities and to empower said communities to fully participate in American society through public education and outreach; and,

To ensure fairness and diversity in judicial appointments by serving on various judicial screening panels and committees

#### DOMINICAN BAR ASSOCIATION HISTORY

The history of the Dominican Bar Association begins with the large migration of people from the Dominican Republic to the City of New York that occurred in the 1960's and 1970's. Many of those migrating over that time were lawyers, doctors, engineers, *etc.*, who left professional careers in the Dominican Republic in search of a better life in the City of New York.

However, after their arrival in the city they quickly found that life would still be difficult despite their professional credentials. Early on most Dominican lawyers, doctors, architects, engineers, etc., struggled because their professional licenses obtained in the Dominican Republic were not recognized by the State of New York. As a result, although professionally trained and experienced, most people were forced to accept employment wherever they could find it, i.e. as laborers, blue-collar workers, etc. Yet, they never abandoned their desire to resume their professional careers in the State of New York.

With that goal in mind they gradually began to hold informal meetings to discuss how they could make the transition. Initially, meetings took place at their respective homes, in local restaurants and in local sporting clubs. As time went on and the number of Dominican lawyers in the city grew, the need to establish their own formal organization became apparent. It was then that four Dominican attorneys began to meet and discuss the creation of an organization dedicated solely to the interests of lawyers, law students and the legal interests of the Latino community.

The driving force in creating that organization was Victor M. Espinal. Along with cofounders Nurys De Oleo, Rosa Leyda Mateo and Aurea Vasquez, they collectively created the American Society of Dominican Attorneys (ASDA) in 1990. At the time, none were admitted to practice law in the State of New York. In fact, given that most Dominican lawyers living in New York at the time where only licensed to practice law in the Dominican Republic, most of ASDA's initial efforts were directed towards assisting those individuals in gaining admission to the bar.

As the years progressed, more Dominican lawyers became admitted in New York. In addition, second and third generation Dominicans, born and raised in this state, also became admitted attorneys in New York. That slow but steady rise shifted ASDA's primary focus away from easing the transition of foreign attorneys to advancing the interests of those attorneys already practicing law within the State of New York. As a result, in 1996 the organization began doing business as the Dominican Bar Association, Inc. to more accurately reflect its membership.

Throughout its history the Dominican Bar Association has demonstrated a commitment to furthering the legal interests of all Latinos and Dominicans in all facets of the community. DBA's efforts have consisted of providing pro bono legal clinics for members of the public, assisting law students by providing scholarships and mentoring, facilitating communication between the bar and the judiciary and actively participating in the selection process of judicial candidates to name just a few activities. While much has been accomplished, DBA looks forward to continuing to perform its work in the present day and into the future.





William Malpica received a Bachelor's Degree from the State University of New York at Albany where he was active in student affairs. Upon graduation, he was selected as a Public Affairs Fellow with the Coro Foundation, a not-for-profit leadership training program in New York.

Will served as Special Assistant to then State Senator Donald Halperin of Brooklyn and worked on the Senator's political bid for New York City Public Advocate. At the conclusion of the unsuccessful campaign, Will was appointed as the Brooklyn Regional Representative to Governor Mario Cuomo and Ombudsman for State Services.

Will graduated from the Fordham University School of Law in 2000. As a law student, he served as Associate Editor on the Urban Law Journal and held numerous positions on Fordham's Latino Law Students Association (LALSA). An evening student, Will attended classes at night while holding rewarding positions at New York Life Insurance Company, the Coro Foundation and the Community Service Society. It was during his time in law school, that Will became keenly aware of the gross under-representation of minorities, particularly Latinos, in law schools and in the legal profession generally. He has been committed to improving educational opportunities for disadvantaged students and to diversifying the racial and ethical make-up of the legal profession.

As a summer associate at Mayer, Brown, Rowe & Maw LLP, Will successfully tapped his firm's resources and collaborated with the Puerto Rican Legal Defense & Education Fund (PRLDEF) to design an annual daylong workshop entitled, "How to Succeed in Law School." The program has provided hundreds of incoming law students with a vital orientation to the rigors of law school. The initiative is among those described in his publication, "Expanding Latino Participation in the Legal Profession: Strategies for Increasing Latino Law School Enrollments" (with Maurieio España, Fordham Urban Law Journal, May 2003).

With Mayer Brown's blessing and its financial support, Will has continued to collaborate with student leaders, bar associations, non-profit organizations and others to devise new and effective approaches aimed at increasing minority representation in the profession. Among them, a judicial internship placement program which provides 15 to 20 new paid internship opportunities; an annual conference of minority law student leaders which facilitates critical exchange among 75 to 100 student leaders from law schools in the region; and an annual mock interview program which gives approximately 50 students each year the opportunity to practice their interview skills with Mayer Brown attorneys.

His passion for diversifying the profession has been highlighted by various legal and general circulation publications including the *New York Times* and the *New York Law Journal*. Will recently spoke regarding law firms and diversity strategies as a member of a panel organized by the New York State Bar Association

As an associate with the law firm of Mayer Brown, Will practices corporate and finance law, specializing in structured finance transactions. His pro bono projects include representing the National Board of the NAACP on general corporate matters, including the drafting of the organization's national constitution and by-laws.

Will was appointed by Mayor Michael Bloomberg to a three-year term on the New York City Commission on Human Rights. The Commission investigates complaints brought by New Yorkers alleging violations of the city's human rights code. One of 14 Commissioners, Will is charged with, among other things, reviewing the decisions of administrative law judges assigned to the Commission's cases.

With is co-founder of the Friends of PRLDEF; chair of the Student Outreach Committee of the Puerto Rican Bar Association; a member of the Corporate Advisory Board of the Committee for Hispanic Children & Families; and a member of the Committee on Recruiting and Retention of Lawyers of the Association of the Bar of the City of New York. In 2003, he was named on of New York's 25 most influential Latinos by the New York Post.

Will lives in Jackson Heights, Queens with his wife, Nury, and their daughter, Rebecca.

#### **OUTSTANDING ACHIEVEMENTS OF:**

#### Victor Miguel Espinal

Victor Miguel Espinal, a dominican-american activist in the New York, Philadelphia, and New Jersey tri-state area since 1966, has been since then providing assistance to non-citizens of the United States, probono publico in civil rights, immigration and human rights, to the present date (2005).

Every month, in a voluntary program, <u>Victor</u> provides a clinic to guide non-chirizens, in any of the 3 states, in combination with local entities and the Consulate General of the Dominican Republic having jurisdiction over each of the principal cities in the tri-state area.

Prior to rendering the immigration orientation with the collaboration of churches, alcoholic anonymous groups, community organizations, etc. Victor was principally providing guidance in the following entities:

- Since 1965 to 1982: Club Deportivo Dominicano, Inc. (New York) serving as President, General Secretary, President of the Softball League Felipe Alou, public relations and columnist (sports) in the local newspapers EL DIARIO-LA PRENSA, Noticias Del Mundo, El Nacional, etc. The Club Deportivo was chartered in New York 3/23/1965.
- 2. Council of Dominican Organizations, Inc., a group of 12 entities with membership in the five boroughs of New York, practising sports and receiving community guidance, English as a second language, immigration assistance to become U.S. citizens and lawful permanent residents of the U.S., and Victor was the founding Director and Counsel, since 1972 to 1982. This entity was chartered in New York (1972) as N-PC.
- 3. National Association of Dominicans Abroad, Inc., chartered in New York as a community guidance entity and for political enhancement (1974). It was founded by <u>Victor</u> and he was the General Director. The entity sponsored forums/fora in all kinds of community needs, mainly for the latino community in the Northern Section of New York City. <u>Victor</u> headed the group until 1983. Campaigns for many candidates in New York were then voluntarily headed as <u>coordinator</u> by Victor.
- 4. As a follow-up professional entity to the Committee of Friends and Graduates of the Autonomous University of Santo Domingo (1978) the founding members NURYS DE OLEO, ROSA LEYDA MATEO, and VICTOR MIGUEL ESPINAL, had chartered the American Society of Dominican Attorneys, Inc. (1990) in New York, to help in the efforts to become licensed members of the different U.S. Bars to members admitted in the Dominican Republic and to organize the lawyers of dominican ancestry or born in the mother country but licensed in the various States of the United States, to get together and achieve positions such as: deans of law schools, judges, law clerks, etc.

The lawyers from Dominican extraction interested in teaching positions were provided with the community basis to be sponsored by local political clubs and the county chairmen to become judges and law clerks.

Victor was the founding president and the director of community legal education from 1990 to November, 1996, when he was replaced by Judge Mendez.

**Enrique R. Acuña**, is currently a 2<sup>nd</sup> year student at the Benjamin Cardozo School of Law. Before attending law school, in his hometown of San Bernadino, California, Enrique was actively involved with a variety of organizations serving the Latino community. He obtained a Bachelor's degree in film and video production from the University of California, Santa Cruz with an impressive academic record.

While in law school, he participated in Cardozo's advocacy program for battered women and the volunteer income tax program in East Harlem. The Cardozo School of Law recognized his commitment to public service by naming him one of the inaugural members of its Public Service Scholar program. Enrique is particularly interested in focusing his studies and professional efforts on labor law to advocate on behalf of Latino workers and is externing at the law firm of Kennedy, Schwartz & Cure.

#### **BRODER & REITER SCHOLARSHIP RECIPIENT**

**Karina A. Garden**, is currently a 2<sup>nd</sup> year student at Brooklyn Law School. When Karina was 8 years old, her mother brought her family to the United States from the Dominican Republic to provide her daughters with better educational opportunities. Karina has taken advantage of those opportunities and before enrolling in law school, she completed a bachelor's degree at Boston University with a double major in psychology and political science.

In addition to maintaining a demanding course load, Karina works full-time as a corporate paralegal to help finance her law school education. Karina also serves as the current president of Brooklyn Law School's Latin American Law Student Association and has consistently made an effort to participate in programs and activities offered to law students through the Dominican and Puerto Rican bar associations.

#### GREENBERG, GREENBERG & GUERRERO SCHOLARSHIP RECIPIENT

Yaneris Mercedes Rosa is a 1<sup>st</sup> year student at Harvard Law School. Yaneris has been committed to public service since she was an undergraduate at Cornell where she was actively involved in the recruitment and provision of support services to Dominican and other Latino students. While maintaining an excellent academic record, she also made time to volunteer at a bilingual education program at Beginning with Children Elementary School in Brooklyn.

Since enrolling in law school, Yaneris has continued to dedicate time to the Latino community by volunteering as a high school mentor through the Learning and Mentorship Project, participating in the Street Law Program, and by serving as alumni relations co-chair of the student organization La Alianza. Yaneris is especially interested in studying immigration law largely because of her own experience immigrating to this country at a young age, with her mother, from the Dominican Republic.

It is a privilege to be honored today by the Dominican Bar Association, with whose members I have been proud to work alongside for years. They are leaders in the community, and their devotion and dedication to justice and the expansion of civil rights and liberties is an example to us all. My State Senate district has a significant Dominican-American population, and I look to the members of the Dominican Bar Association and other Dominican leaders for guidance. I am grateful for their assistance in tackling the problems facing our district, and New York State as a whole.




